# **MEETINGS BY THE MINUTE**

January 6, 2015

The meeting was called to order at 7:05pm. There were 37 members and 3 guests present. Jon Webb reported the club treasury stands at \$4731.28. Curtis Welch, Juniors Director, informed the club that Margie Bootenhoff had donated \$2,275 to the Junior Club in memory of her late husband. A memorial was discussed and the Junior club management will present several ideas for the membership to consider prior to implementing a memorial to Mr. Bootenhoff. No conservation projects are currently pending but with moderation of the weather the club will be looking for ideas and locations. If you have a habitat project to be considered, please contact Conservation Director George Mauries. Colorado Federation rep Jeremiah Hofstettter updated the club on the STQT to be held March 15th to 22nd at Tenkiller Lake in OK. The host resort will be Fins and Feathers, please make lodging reservations as soon as possible. The tournament fee is \$255 including the Big Bass pot. Jack Chaney made a motion to hold an Open Tournament at Pueblo in March to help fund the State Team. 20 Percent of the proceeds will be donated to the State Team. The motion carried. In a unanimous vote the club approved the amendment to the Constitution and By Laws and adopted the Colorado Bass Nation tournament rules. Specific language is as follows:

#### ARTICLE V: TOURNAMENTS

The Chapter shall utilize Colorado Bass Nation (CBN) tournament rules and regulations with the following exceptions; Nets for landing all fish are to be allowed, DBM will follow a co-angler (split) format as outlined in DBM Tournament Rules, Off-Limits period will follow DBM Tournament Rules. Enforcement and interpretation of these rules and regulations will be by the Tournament Director, and the tournament committee and compliance is mandatory.
