MEETINGS BY THE MINUTE

May 13th, 2015

President Brandon Genova called the meeting to order at 7:08 pm. There were 31 members and 1 guest in attendance. STQT forms were accepted and 16 members were planning on competing in the tournament. Curt Welch, Juniors Director, updated the club on the recent junior events held at Donovan's and Swift ponds. The Swift Pond outing also served as the State Qualifying event for the Juniors. Curtis reported a 6.2 lb. large mouth caught by one of the kids was a highlight of the day.

Ryan Wood was chosen from over 200 young anglers to be a member of B.A.S.S.'s High School All American Team. Only 12 High School fishermen make the team. The club congratulates Ryan on this great achievement.

The club held a Hot Dog and Brat fund raiser at BPS on April 11th and 12th. The fund raiser netted the club \$1,450. Event Coordinator Tom Grace thanked the members for their hard work. Tom also mentioned the Ft. Carson Kids Day scheduled for June 20th and asked the membership to support this very worthwhile program.

Marin Marinov was thanked for his generous \$300 donation to the Junior Club.

Larry Triplet will be Colorado Bass Nation's representative to the BASS Nation Tournament to be held in Monroe, LA

in November. Larry finished 3rd overall and was the highest placing Colorado fisherman in the Western Divisional Tournament held at Clear Lake, CA in April. Larry spoke on how he found his fish and the techniques he used to catch a limit each day, a feat accomplished by few competitors.

Brandon Genova made a motion to cover \$500 of Larry's expenses for the National Tournament. Jeremiah Hofstetter seconded and the motion carried.

Gary Schipporeit explained the NED Rig and how and where he fishes it. The NED rig is 1/2 of a stick worm and a 1/16th oz. mushroom head jig. The rig remains tail up and works similar to a shakey head. Gary suggested a slow retrieve and shake motion makes this finesse presentation a winner.

Tournament Director, Troy Weisenberger, announced the Pueblo Tournament winners and payouts. 1st Larry Triplet \$359, Big Bass \$152 and 1/2 Boat Weight \$76, 2nd Jeff Winnicki \$256, 3rd Tom Grace \$205, 4th Jim Coveney \$128, 5th Jeff Vermillion \$78 and Jeremiah Smith \$76 1/2 Boat Weight.

Steve Ehrman made a motion to reimburse Tom Grace for \$55.94, (flowers for Laura Lee at BPS) and \$130 (printing DBM decals). Gene Rohr seconded and the motion carried in a voice vote.

The club raised \$90 in the raffle and Brandon Genova won the Skeet Reece combo.

The meeting was adjourned at 8:35 pm.
