## MEETINGS BY THE MINUTE

June 1, 2016

President Brandon Genova called the meeting to order at 7:15pm, there were 38 members present. Jon Webb reported the Treasury balance to be \$3,830.04. George Mauries has been appointed to Conservation Director for the Colorado Bass Nation. George informed the membership that his new position is time consuming and he asked the membership appoint a new DBM Conservation Director. The board will discuss the opening and appoint a replacement. The club thanked George for his contributions as Conservation Director. Audrey McKinney, CBN President, updated the club on various discounts and promotional offers available to members of Colorado Bass Nation. CBN has the largest membership of all of the Western states. CBN representatives are working with local authorities to educate them as to the non-profit status of CBN and its affiliated clubs. Many municipalities and Rec and Parks officials believe that our tournaments are for profit and therefore treat and charge us as they would a commercial venture. Audrey reported nearly \$12,000 is available for conservation projects.

Jeremiah Hoffstetter, our CBN rep, reported on the STQT recently held at Tenkiller Lake in OK. 31 Boaters and 24 Co-Anglers from across the state made the trip. The water clarity varied from clear at the dam to muddy in the river. A 13 to 16 inch protected slot challenged the fishermen and

provided some comical moments at the weigh in as fish as small as .25 lbs and as large as 5.92 lbs were weighed in. The following DBM members made the State Team: Chad Phillips 3rd, Jeremiah Hofstetter 6th, Mark Warren 8th, Larry Triplett 9th, Brandon Genova Alternate. Co-Anglers making the team are Marin Marinov 2nd, Steve Ehrman 4th, and Bobby Martin 9th weighing in the Big Bass of the tourney 5.92 Lbs.

Curtis Welch, Youth Director, updated the club on the recent Junior event held at Liberty Springs/Carlson Pond. Gene Polombo with U.S. Warriors will be hosting a Day on the Lake for veterans on June 4th. The membership was asked to provide boats for the Veterans. Tom Grace announced that some of the tackle recently donated to the Junior club is available for sale as a fund raiser for the Juniors. Contact Tom Grace for additional information.

Tom Grace, Event Coordinator, asked the membership to participate in the CAST Event June 4rd and the Ft. Carson Kids Day June 18th. The raffle raised \$130 and was won by Gene Rohr.

Jeremiah Hofstetter made a motion to increase the travel tourney fee to \$60 effective next season. Jack Chaney seconded the motion. An email vote will be held and the results announced at the next meeting.
